DUES

All dues are due and payable January 1 and become delinquent April 1 at which time all benefits expire including loss of death benefit, voting privileges and Company subscription to the PA FIREMAN

Must be a member of a Pennsylvania Chartered Emergency Service Organization

Associate member (out of state) Non beneficial membership **\$5.00**

Organization MEMBERSHIP \$20.00

Must be a Pennsylvania Chartered Emergency Service Organization. All member organizations may name a delegate to represent them as a voting member at the Convention. Member Organizations receive a subscription to the PA FIREMAN as part of their membership services. Dues are due and payable January 1 of each year and expire no later than March 31 of the following year. PA Fireman subscription period is from April through March.

100% MEMBERSHIP (per Member) \$8.00

A Pennsylvania Chartered Emergency Service Organization may propose for membership in the organization (as insured members) the entire membership of the company regardless of age. The members shall be insured members so long as the yearly dues are duly paid.

SCHOLARSHIPS

Any person who is an active member of a state, county, municipal, community, industrial or federal fire department, located within the Commonwealth of PA., and who has demonstrated proficiency as a member or children of deceased firefighters that were a member of the Firemen's Assn. of the State of PA or children of members of the Firemen's Assn. of the State of PA or grandchildren if Scholarships are available. A person need not be a member of the State Association to submit an application.

All entries must come from a Career or Volunteer Fire Company/Department duly chartered in the Commonwealth of Pennsylvania and is a member in good standing of the Firemen's Association of the State of Pennsylvania.
